Fred Brezel seconded the motion. Vote was taken. Motion carried unanimously.


Turnback Road Agreement for McCracken and Countryview Roads.

Fred Brezel made a motion to enter the agreement with PennDot. Shari Kreutz seconded the motion. Vote was taken. Motion carried unanimously.


Pay the Bills: Shari Kreutz made a motion to pay the bills. Brian McMurdy seconded the motion. Vote was taken. Motion carried unanimously.
