

# WORTH TOWNSHIP MINUTES

June 2, 2026

Temporary Chairman of the Board of Supervisors Shari Kreutz called the meeting to order with the Pledge of Allegiance to the flag. Those present, along with Ms. Kreutz, were Supervisors Brian McMurdy, Fred Brezel, John Martin and Dave Tyson.

Shari Kreutz made a motion to accept the May Meeting minutes. Fred Brezel seconded the motion. Vote was taken. Motion carried unanimously.

Shari Kreutz read the Treasurer's Report for May. Shari Kreutz made a motion to accept the report. Brian McMurdy seconded the motion. A vote was taken on the motion. Motion carried unanimously.

Public Comments: A Township resident raised many issues with the Board of Supervisors. He feels the Township Secretary does not need to work 40 hours a week. The road crew shouldn't mow the berms continuously all summer. According to this resident, he repeatedly spoke to Brian McMurdy about trees on McCracken Road. He also feels clean-up days are not helping with littering on the roads.

Fred Brezel countered all his points by saying that the Township Secretary does need to work 40 hours a week due to her workload and that she is a great secretary. Brian McMurdy defended the summer mowing by explaining site distance is needed, especially at intersections. Clean up day is very well received by many Township Residents. Trees on McCracken Road are in Scott Township, Lawrence County. The state has not completed the paperwork stating that the portion of McCracken Road is now under Worth Township in Butler County.

Vote was taken. Motion carried unanimously.


